## AFFECTED PRODUCTS

Environmental systems articles manufactured and/or distributed by Seamech International, Inc. (Seamech), now known as Bascom Hunter Technologies, Inc. (Bascom), for installation on the Federal Aviation Administration (FAA) type-certificated Eclipse Aerospace, Inc., Model EA500 airplanes.

## **PURPOSE**

This notification advises all aircraft owners, operators, manufacturers, maintenance organizations, and parts suppliers and distributors of Eclipse Aerospace, Inc., aircraft environmental systems articles manufactured and/or distributed by Seamech and Bascom, without FAA production approval.

## **BACKGROUND**

Information discovered during an FAA Suspected Unapproved Parts (SUP) investigation revealed that between January 2019 and August 2023, Seamech and Bascom, located at 7110 W Augusta Ave. Glendale, Arizona 85303, produced and sold numerous environmental system articles for installation on Eclipse Aerospace, Inc., Model EA500 airplanes, without the approval and authorization of the FAA or Eclipse Aerospace, Inc., the FAA approved design holder.

The environmental system articles produced and sold by Seamech and Bascom may have these characteristics:

- 1. They were sold without an FAA Form 8130-3, Authorized Release Certificate, Airworthiness Approval Tag issued by FAA approved design holder Eclipse Aerospace, Inc.
- 2. The certification and shipping documents were issued by Seamech International, Inc. or Bascom Hunter Technologies, Inc., and not by the FAA approved design and production approval holder Eclipse Aerospace, Inc.
- 3. They were not marked with the letters "FAA-PMA".

### RECOMMENDATIONS

FAA regulations require that type-certificated products conform to their type design. The FAA encourages aircraft owners, operators, manufacturers, maintenance organizations, and parts suppliers and distributors to inspect their aircraft and/or aircraft parts inventory for any Seamech International, Inc., or Bascom Hunter Technologies, Inc., supplied environmental system articles. If these articles are found in existing inventory, the FAA recommends that they be quarantined to prevent installation until a determination can be made regarding their eligibility for installation.
