<sup>1</sup> As defined in 49 USC 47106(f)(4), a covered airport must meet the following two criteria: (1) it must host at least 0.25% of systemwide annual enplanements, i.e., it must be a large- or medium-hub airport, and (2) it must have one or two air carriers compose a simple majority (i.e., >50%) of its annual enplanements. The FY26 list is based on CY 2024 enplanement data.

<sup>2</sup> These dates reflect original plans or plan updates whether based on time or triggering events. Some airports that are not covered in FY 2026 may have been covered in prior years.

<sup>3</sup> OWT means "Only when triggered". The covered airport has met its requirement for an initial plan and two updates. Further updates would only be required when the airport has a triggering event either an airport executes a new master lease and use agreement, or significantly amends a lease and use agreement, including an amendment due to use of Passenger Facility Charge financing for gates or an airport files a competitive access report as required by 49 USC § 47107(r) stating it had denied access to an air carrier for gates or facilities within the last six months.

<sup>4</sup> Locations with due dates shown have been or will be notified individually of the filing requirement.
