I understand you most recently attended the last O' Hare Noise Compatibility Commission's meeting. Thank you for your attendance there and continued support of the communities that help make up that volunteer organization.

As a state representative, I am committed to offering my constituents the opportunity to express their concerns. This includes continued health concerns about the airport issues that affect their families and their lives.

I understand that when and if runway 9C27C gets built, Group Six FAA approved jet aircraft will be using this runway for landings and possible takeoffs at night.

Due to the size and scope of these types of air operations, many constituents have made it known they are worried about this. I want to make sure my constituents' voices are heard, so I'm wondering if there are any options to address this, while still carrying out your responsibilities.

I've also heard concerns about the potential health effects of low flying planes flying over Maine South High School and would like to see if those can be addressed as well.

It is therefore, my concern that we are looking at further and direct potential health issues for these already impacted families as well as the attending students while outside and involved in school activities.

Thank you in advance for giving me an opportunity to seek relief and the proper accommodations for this already highly impacted community.

In conjunction with the already approved State of Illinois Bill S.R. 690, we would ask that you please conduct an official investigation into the Sunday evenings and those ATC's assigned to the towers as well as the Night Time Control Departure Desk, and with Mr. Bob Flynn the ATC, Tower Manager, as to why, on a repeat basis, the pilots and planes have not followed Fly Quiet protocol.

If other major Hubs such as the San Francisco airport and others can have a working Fly Quiet program - then why can't we?
