Re: AIP Updates – Fiscal Year (FY) 2020

Dear Airport Sponsor:

Thank you for submitting your revised Capital Improvement Program (CIP) and corresponding data sheets. If you have not provided it, they were due December 15, 2019, please reach out to Suki Gill, Assistant Manager, at Sukhbir.Gill@faa.gov, for an extension. We have completed our review and we have attached a list of projects that we are optimistic could compete favorably for AIP funding in FY20.

AIP funds are subject to annual Congressional appropriation and the attached list is not an FAA commitment of funding for the identified projects. The list is intended to provide you with information for planning purposes so that you can be prepared should funds be available.

Federal Fiscal Year 2020 Projects (current year)


- Due to the extensive review, the FAA expects only minor revisions to FY20 due to the new NPIAS/ACIP Order distributed in September 2019, which changed most work codes and NPR values.
- Airport sponsors should be taking steps to get these projects under grant in FY20 in accordance with the attached planning dates. The pre-application can be found here: https://www.faa.gov/airports/eastern/nyado_bulletin/media/17-007-nyado-sponsor-grant-pre-application-checklist.pdf
- **Planning, Environmental, Design Projects** – To get ahead in the programming process, we ask you submit a final application for planning/environmental studies and design projects by **January 31, 2020**. A pre-application is not necessary and a Final Grant Application can be submitted.
- **Final Grant Applications** – We are requesting final grant applications to be submitted much earlier this year, in order to program early. The new date is **May 15, 2020**. The Federal Register Notice will provide a final date. As a result, the submission of bid tabulations to the ADO for concurrence date is changed to **February 1-May 1, 2020**.
- **Eligibility Determination** – For projects requiring eligibility determination, documentation was due September 30, 2019. Please include the determination in your pre-application provided by your assigned PM for the following projects: Modification of Standards, BCA's, equipment inventory (ARFF, SRE, aircraft deicing, etc.) or proration (buildings, utilities, etc.).

- **SAM Registration** - Be sure your SAMs registration is up to date through the Federal Audit Clearinghouse (FAC). <https://www.gsa.gov/about-us/organization/federal-acquisition-service/office-of-systems-management/integrated-award-environment-iae/sam-update>
- **Intergovernmental Review** – As per the AIP Handbook, 3-19. *Intergovernmental Review* (see link below), you are required to coordinate projects through your appropriate local governmental contact for projects listed in Table 3-12.
This review will need to be complete prior to submitting a final grant application. Please include the response from the local agency in the final application for confirmation. Allow sufficient time of at least 60 days for this review to be complete, if not already accomplished during the environmental or planning stage.
