Subject: Cancellation of Advisory Circulars and Orders Following "313" Review by OPRs

---

Section 313 of the FAA Modernization and Reform Act of 2012, Public Law 112-95, required the FAA, in consultation with representatives of the aviation industry, to determine the root causes of inconsistent interpretation of regulations by the Flight Standards Service (AFS) and Aircraft Certification Service. In response to the requirements outlined in section 313 the FAA chartered the Consistency of Regulatory Interpretation Aviation Rulemaking Committee (ARC). The ARC's primary recommendation included cancelling outdated or conflicting guidance. To address the recommendation AFS completed a revalidation review in January 2015. As a result of this review, AFS is requesting the cancellation of the following Advisory Circulars and order because they contain archaic information or have incorporated into other guidance.
