Select either filtered or unfiltered NAS data. **Note:** For the purposes of this form, the term "filtered NAS data" means NAS data that has been filtered via a software process to remove all Sensitive Flight Data. Unfiltered NAS data contains one or more data elements associated with Sensitive Flight Data.
6. For Item 6a, indicate if this request is directly associated with a Federal agency or State, Local, Tribal, or Territorial (SLTT) government entity, if applicable. If "Yes" for 6a, identify the specific Federal or SLTT government entity in 6b.
