**ACCORDINGLY, AND UNTIL FURTHER NOTICE, THE CURRENCY
REQUIREMENTS SPECIFIED BY FAA ORDER JO 7210.3BB, FACILITY
OPERATION AND ADMINISTRATION, ARE AMENDED AS SPECIFIED HEREIN.**

CURRENCY REQUIREMENTS FOR FSS REMAIN UNCHANGED.

**CHANGE FAA ORDER JO 7210.3BB, FACILITY OPERATION AND
ADMINISTRATION, PARA. 2-3-3, REQUIREMENTS, SUBPARAGRAPH b,
CURRENCY, SUBPARAGRAPH 2, TO AND INCLUDING SUBPARAGRAPH (f)**

TO READ AS FOLLOWS:

UNTIL FURTHER ADVISED, AIR TRAFFIC MONTHLY CURRENCY REQUIREMENTS ARE REDUCED BY HALF. THE MINIMUM HOUR PER POSITION IS WITHDRAWN. DUAL CURRENCY TMCS AS WELL AS PERSONNEL AT TOWER/RADAR (UP/DOWN) FACILITIES ARE REQUIRED TO GET 8 HOURS TOTAL AT THE DIRECTION OF THE ATM.

SUBPARAGRAPH b2 (f) (1) THROUGH (3) IS DELETED. NO FURTHER CHANGES TO PARAGRAPH.
