SUBJ: OpSpecs A006 and A007 for Part 129

- 1. Purpose of This Notice. This notice provides revised guidance for Federal Aviation Administration (FAA) offices and inspectors with oversight responsibility for operators conducting airplane operations under Title 14 of the Code of Federal Regulations (14 CFR) part 129. This notice amends operations specification (OpSpec) A006, Foreign Air Carrier Management Personnel. It also incorporates information from OpSpec A007, Other Designated Persons. This notice decommissions the A007 template.
- **2. Audience.** The primary audience for this notice is Flight Standards District Offices (FSDO), International Field Offices (IFO), International Field Units (IFU), principal operations inspectors (POI), principal maintenance inspectors (PMI), and principal avionics inspectors (PAI) with oversight responsibility for operators certificated under part 129. The secondary audience includes Flight Standards branches and divisions in the regions and in headquarters (HQ).

- **4. Explanation of Policy Changes.** The International Programs and Policy Division (AFS-50) has amended OpSpec A006 for part 129. This amended OpSpec A006 incorporates the information from OpSpec A007 and includes:
 - The renaming of OpSpec A006 to Foreign Air Carrier's Personnel, Designated Agent, and Other Persons:
 - The removal of Telex information;
 - The renaming of "State civil aviation authority or State Government official" to "responsible State Government official";
 - The replacement of the term "Internet address" with "e-mail";
 - The replacement of the term "Facsimile" with "fax"; and
 - The addition of e-mail and fax to the management personnel table.

- **5. Action.** This is a mandatory change affecting principal inspectors (PI) with responsibility for the issuance, amendment, and oversight of OpSpecs A006 and A007. When amending either OpSpec A006 or A007, the new A006 template should be used and the A007 OpSpec, if issued, must be archived. This action must be accomplished by the template expiration date associated with the previous revision of A006 in the WebOPSS system.
