## SUBJ: Assistant Administrator for NextGen Organizational Change

**1. Purpose of this Notice.** This notice announces the establishment of the Interagency Planning Office (ANG-I); the consolidation of the Advanced Concepts & Technology Development Office (ANG-C) and the NAS Lifecycle Integration Office (ANG-D) into the Portfolio Management & Technology Development Office (ANG-C); the restructuring of the NAS Systems Engineering Services Office (ANG-B) into the NAS Systems Engineering Integration Office (ANG-B); and minor organizational changes to the William J. Hughes Technical Center Office (ANG-E).

**2. Audience.** This notice applies in general to the Federal Aviation Administration (FAA) and specifically to ANG employees.

**4. Explanation of Changes.** This notice describes the creation of ANG-I, the restructuring of ANG-B, the consolidation of ANG-C and ANG-D into a restructured ANG-C and some minor restructuring within ANG-E.

(2) Provides corporate leadership, advisory, and consultative support to the Associate Administrator for NextGen and to the FAA on a wide variety of complex and often highly visible issues.

(3) Responsible for identifying, researching, coordinating, and prioritizing multi-agency NextGen issues.

(4) Manages and builds interagency relationships, representing NextGen to the partner agencies.








