SUBJ: Adding Email Fields to OpSpecs/MSpecs/LOAs A001, A006, and A007

- 1. Purpose of This Notice. This notice announces revisions to operations specifications (OpSpec), management specifications (MSpec), and Letters of Authorization (LOA) A001, A006, and A007, as applicable, for Title 14 of the Code of Federal Regulations (14 CFR) parts 91, 91 subpart K (part 91K), 121, 121/135, 125 (including part 125 Letter of Deviation Authority (LODA) holders), 133, 135, 141, and 145 operators and agencies to capture email address information for responsible personnel.
- **2.** Audience. The primary audience for this notice is the Flight Standards Safety Assurance offices' and International Field Offices' (IFO) principal inspectors (PI) and aviation safety inspectors (ASI) assigned to operators under parts 91, 91K, 121, 121/135, 125, 125 LODA holder, 133, 135, 141, and 145. The secondary audience includes the Safety Standards and Foundational Business offices.

- **4. Background.** Title 14 CFR regulations on air operator and air agency management and technical personnel identify the positions and qualifications for those personnel by title or equivalent role according to the 14 CFR part of operations. Additionally, Title 49 of the United States Code (49 U.S.C.) § 46103 requires air carriers to designate an agent for service to receive legal correspondence on behalf of the operator or agency. All of the personnel accountable to the FAA are listed on the operator's or agency's OpSpecs, MSpecs, or LOAs, as applicable, primarily through OpSpecs/MSpecs/LOAs A006 and A007. However, the OpSpecs/MSpecs/LOAs do not include business contact information for FAA-accountable personnel. This notice revises the OpSpec/MSpec/LOA templates identified in the table below to add a field to capture email address information.

#### 5. Discussion.

**a. Email Address Fields.** In light of more widespread use of email as a communication method, the FAA is adding email fields to the templates for the following OpSpecs/MSpecs/LOAs:

- **b.** Additional Changes. Most individual part 91 LOAs authorize the responsible person for the particular operations to include contact information with an email address. The General Aviation and Commercial Division (AFS-800) has added a section for the responsible person to the part 91 LOA A001 to identify a central responsible person for the operator with an email address. In addition, AFS-800 has:
  - Made minor editorial changes to subparagraph 2b of the part 91 LOA A001 template,
  - Removed pilot certification information from the part 133 LOA A006 template, and
  - Added a telephone number field to the part 133 LOAs A006 and A007 templates.
- **c. OpSpecs/MSpecs/LOAs.** Appendices to this notice show revised language and placement of the added email fields. This notice contains the following:

- 2. A change in the principal base of operations location constitutes an administrative change only to this Letter of Authorization (LOA) A001 and would not require nor preclude a new inspection.
- a. The existing authorizing documents issued to the operator are still valid and not intended to be reissued due to a change in the operator's principal base of operations location.
- b. If the operator relocates its principal base of operations listed in subparagraph 1 above, it must notify, in writing, the losing Flight Standards office of its new location and mailing address within 30 calendar-days following relocation and, if applicable, advise the losing Flight Standards office of the receiving responsible Flight Standards office to which the operator has relocated.
- 3. The attached waiver, authorization, and/or deviation documents are effective as of the "Date Approval is Effective" listed in each document, and those issued without an expiration date shall remain in effect as long as the operator listed in subparagraph 1 above continues to comply with all applicable regulations and the requirements, limitations, or provisions of each authorizing document, or until any of the following:
  - a. It is voluntarily surrendered by the operator for cancellation;
  - b. The operator ceases to be the operator of the aircraft listed in the applicable authorization;
  - c. It is canceled, rescinded, or revoked by the FAA;
  - d. The responsible person signing the authorizing document relinquishes responsibility;
- e. The aircraft or listed equipment is no longer used for that operation and should be removed from the authorization;
  - f. The aircraft listed on the authorization change(s) registration number(s); or
- g. The aircraft listed on the authorization is issued an experimental Special Airworthiness Certificate for research and development (R&D) or changes projects associated with an experimental Special Airworthiness Certificate for the purpose of R&D.
- 4. <u>Responsible Person</u>. If the responsible person as the signee changes for an authorization, the responsible person or the operator should notify the issuing office of the change, identify the responsible person replacement, and request an updated authorizing document. The responsible person should have ongoing knowledge of the operations of the aircraft and may be the

individual who acts as operator or, if the operator is a legal entity, an officer, employee, or person duly designated to sign on behalf of the operator.
