SUBJ: Mandatory Reissuance of Operations Specification (OpSpec) A001, Issuance and Applicability, for Parts 121, 135, and 121/135 Certificate Holders

- 1. Purpose of This Notice. This notice announces a mandatory revision to OpSpec A001 for Title 14 of the Code of Federal Regulations (14 CFR) parts 121, 135, and 121/135 combined certificate holders (CH) to modify the language in subparagraph d.
- **2. Audience.** The primary audience for this notice is Flight Standards (FS) Safety Assurance principal inspectors (PI) with oversight responsibilities for parts 121, 135, and 121/135 CHs. The secondary audience includes FS personnel in the Office of Safety Standards and the Safety Risk Management Division of the Office of Foundational Business (AFB-400).

- **4. Background.** OpSpec A001, subparagraph d was added to the parts 121, 135, and 121/135 templates on August 21, 2002, in Revision 02b. The intent of subparagraph d was to eliminate the need for an operator to obtain a separate Letter of Authorization (LOA) to conduct flights under 14 CFR part 91 for crewmember training, maintenance tests, ferrying, repositioning, and the carriage of company officials.
- **a.** Revision 02b. The language in subparagraph d stated, "Certificate holders conducting flights for training, maintenance tests, ferrying, re-positioning, the carriage of company officials and their guests, and the carriage of an athletic team, sports, choral, or similar group having a common purpose, may use the applicable authorizations in these OpSpecs for those operations in lieu of a LOA, provided the flights are not conducted for compensation or hire and no charge is made under the applicable provisions of Parts 91 and 125."
- **b.** Revision 02c. In 2003, in response to changes to 14 CFR parts 121, 125, 135, and 121/135, OpSpec A001 templates were revised to Revision 02c to change the text in subparagraph d from "...no charge made under the applicable provisions of Parts 91 and 125," to: "...no charge of any kind is made for the conduct of the flights."

c. Revision 030. The language in parts 121, 135, and 121/135 OpSpec A001, subparagraph d was recently brought to the FAA's attention by the National Transportation Safety Board (NTSB) in response to an accident. The Air Transportation Division (AFS-200) reviewed the language and history and believes that it is overreaching to say a CH cannot charge for anything related to the aircraft movement when the regulations do not prohibit it. Therefore, AFS-200 is removing the reference to "no charge of any kind is made for the conduct of the flights." The language in OpSpec A001, subparagraph d for parts 121, 135, and 121/135 is being changed to read as follows:

- "d. The certificate holder is authorized to conduct flights under 14 CFR Part 91 for crewmember training, maintenance tests, ferrying, repositioning, and the carriage of company officials using the applicable authorizations in these operations specifications, without obtaining a Letter of Authorization (LOA), provided the flight does not involve the carriage of persons or property for compensation or hire."
- **5. Guidance.** The revised OpSpec A001 templates for parts 121, 135, and 121/135 are available in the Web-based Operations Safety System (WebOPSS). This notice contains the following:

- **6. Action.** This is a mandatory revision to OpSpec A001 for parts 121, 135, and 121/135 CHs. PIs must reissue OpSpec A001 within 60 days of the date of the template HQ Control Date in WebOPSS. This action must be accomplished following the procedures in 14 CFR part 119, § 119.51 for Administrator-initiated amendments to a CH's OpSpecs.
