SUBJ: OpSpec/MSpec A034, Advanced Qualification Program

- 1. Purpose of This Notice. This notice announces a mandatory revision to operations specification (OpSpec)/management specification (MSpec) A034 issued to operators for authorization to conduct training in accordance with an Advanced Qualification Program (AQP) under Title 14 of the Code of Federal Regulations (14 CFR) parts 91 subpart K (part 91K), 121, 135, and 121/135 combined certificate holders (CH). OpSpec/MSpec A034 has been revised to properly identify the approved AQP curricula in accordance with part 121 subpart Y. This is a mandatory revision that requires reissuance of OpSpec/MSpec A034.
- **2.** Audience. The primary audience for this notice is the Flight Standards (FS) Safety Assurance offices' principal inspectors (PI) and aviation safety inspectors (ASI) assigned to operators authorized to conduct training in accordance with the AQP under parts 91K, 121, 135, and 121/135 combined CHs. The secondary audience includes the Safety Standards and Foundational Business offices.

- **4. Background.** OpSpec/MSpec A034 was revised to accommodate all job functions and positions approved in current AQP training programs. This revision to OpSpec/MSpec A034 includes three tables for parts 121 and 121/135 and two tables for parts 91K and 135 with specific positions, including job functions; aircraft makes, models, and series (M/M/S); curricula; initial approval dates; final approval dates; and comments. The instructions for completing OpSpec/MSpec A034 are located in the updated FAA Order 8900.1, Volume 3, Chapter 18, Section 3, Part A Operations Specifications—General. The instructions for completing OpSpec/MSpec A034 in Order 8900.1, Volume 3, Chapter 21, Section 4, The Advanced Qualification Program Approval Process, have been removed.

- (2) Order 8900.1, Volume 3, Chapter 21, Section 4 has been updated to remove the instructions for completing OpSpec/MSpec A034.
- **6. Action.** This is a mandatory revision to OpSpec/MSpec A034 for parts 91K, 121, 135, and 121/135 with a compliance date of 60 calendar days from the effective date of this notice. This action applies only to those PIs who are responsible for issuing or revising operator authorizations to administer an AQP training program. PIs should review this notice and the revised Order 8900.1 guidance for issuance of OpSpec/MSpec A034 and provide this notice to the operators for whom they are responsible. Prior to issuing or reissuing the revised OpSpec/MSpec A034, review the operator's approved AQP training program's curricula to ensure the required content to be listed is present.
