SUBJ: Implementation of Powered-Lift

1. Purpose of This Notice. This notice provides updates to the list of documents that have published, and will publish, in support of Title 14 of the Code of Federal Regulations (14 CFR) Part 194, Special Federal Aviation Regulation No. 120—Powered-Lift: Pilot Certification and Training; Operations Requirements.

Note: This is a guidance document. Its content is not legally binding in its own right and will not be relied upon by the Department as a separate basis for affirmative enforcement action or other administrative penalty. Conformity with the guidance document is voluntary only. Nonconformity will not affect rights and obligations under existing statutes and regulations.

- **2.** Audience. The primary audience for this notice is Flight Standards (FS) Safety Assurance principal inspectors (PI) with oversight responsibilities of operators adding or using powered-lift in accordance with 14 CFR parts 91, 91 subpart K (part 91K), 135, 136, 141, and 142. The secondary audience includes certificate holders (CH) and designees operating powered-lift, as well as FS personnel in the Office of Safety Standards (OSS).

- **4.** Cancellation. This notice cancels Notice N 8900.720, Implementation of Powered-Lift, dated November 21, 2024.
- **5. Background.** On June 14, 2023, the FAA published a Notice of Proposed Rulemaking (NPRM), Integration of Powered-Lift: Pilot Certification and Operations; Miscellaneous Amendments Related to Rotorcraft and Airplanes (88 FR 38946). The FAA finalized this proposal on November 21, 2024, by publishing the Final Rule for Part 194, Special Federal Aviation Regulation No. 120—Powered-Lift: Pilot Certification and Training; Operations Requirements (89 FR 92296). The final rule addressed the regulatory barriers that existed for the safe integration of this new category of aircraft into the National Airspace System (NAS).

a. Changes to Regulations. The final rule contained permanent changes to existing regulations and created the new Special Federal Aviation Regulation (SFAR) 120, which is specific to the powered-lift category of aircraft. SFAR 120 can be found in part 194, and a listing of the regulatory sections that contain the permanent rule changes due to this final rule are in Appendix A of this notice. This final rule enables powered-lift operations to be conducted under 14 CFR parts 91 and 91K (General Operating and Flight Rules), 97 (Standard Instrument Procedures), 135 (Commuter and On-Demand Operations), 136 (Commercial Air Tours), 141 (Pilot Schools), and 142 (Training Centers).

b. Pilot Certification. The SFAR also created alternative pathways for pilot certification, with specific minimum prerequisites, that are available in addition to the requirements currently stipulated in 14 CFR part 61 for powered-lift.

6. Discussion.

- **a.** Regulatory Review. The FAA completed a comprehensive review of the regulations and determined that although many regulations were not aircraft category-specific, the existing regulations that were aircraft category-specific required revision to incorporate the powered-lift category of aircraft. The FAA also determined that due to advancements in technology, novel aircraft designs and operational uses, and the lack of any civil powered-lift available resulting in few to no civilian rated powered-lift pilots, there needed to be some flexibility and alternatives for pilots to obtain a powered-lift category rating. The 14 CFR parts that have been created or amended are listed in Appendix A.
- **b. Document Revisions.** The introduction of civilian powered-lift also required the FAA to create and revise documents, such as advisory circulars (AC), FAA orders, notices, operations specifications (OpSpecs), management specifications (MSpecs), training specifications (TSpecs), and Letters of Authorization (LOA), on a magnitude never attempted before. Therefore, the FAA will use a phased-in, timed approach for the publication of the documents related to powered-lift, enabling the FAA to publish the documents required to get pilots qualified and operations with powered-lift started first, and then phase in the other documents that do not prevent initial powered-lift operations. To accomplish this document phase-in, the FAA conducted a review of the documents being revised, set a priority level for each document, and created a document schedule, which is contained in Appendices B and C of this notice.
- **7. Action.** No action is required. This notice is informational only.
- **8. Disposition.** We will not incorporate the information in this notice into FAA Order 8900.1 before this notice expires.
