**SUBJ:** Temporary Moving Airspace Reservations

- 1. Purpose of This Notice.** This notice deletes temporary moving reservations from FAA Order JO 7110.65, Paragraph 13-2-2, a.8.(a) (9) as being considered a conflict probe limitation.
- 2. Audience.** This notice applies to the following Air Traffic Organization (ATO) service units: En Route and Oceanic, Terminal, Mission Support, and System Operations; and all associated air traffic control facilities.
- 3. - 4. Explanation of Policy Change.** This change amends FAA Order JO 7110.65, Air Traffic Control, Paragraph 13-2-2, to remove any confusion with a conflict probe limitation.
- 5. a. Procedures.** Amend Paragraph 13-2-2 to read as follows:

**13-2-2. CONFLICT DETECTION AND RESOLUTION.**

Delete Subparagraph a.8.(a)(9) Para. 8-6-3 - Temporary Moving Airspace Reservations.

Re-number Subparagraph a.8.(a) (10) to read: a.8.(a)(9) Para 8-8-5-VFR Climb and Descent

No further changes to paragraph.

**b. Action.** Facility managers must ensure the provisions of this notice are briefed to operations managers, front-line managers, controllers-in-charge, and air traffic controllers in areas of specialization/facilities prior to the use of these procedures.

- 6. Distribution.** This notice is distributed to the following ATO service units: Terminal, En Route and Oceanic, System Operations Services, and Mission Support; ATO Safety and Technical Training; the Air Traffic Safety Oversight Service; and the William J. Hughes Technical Center.

**7. Background.** FAA Order 7110.65, Chapter 13, Section 2, Ocean 21, Paragraph 13-2-2, a.8. contains a list of Conflict Probe Limitations pertaining to the Ocean 21 ATC system, which includes Paragraph 8-6-3, Temporary Moving Airspace Reservations. Ocean 21 functionality supports the application of lateral, longitudinal, and vertical separation to Temporary Moving Airspace Reservations; therefore, to avoid confusion, it is practical to remove it from the Conflict Probe Limitations list.
