1. PARAGRAPH NUMBER AND TITLE:

4-6-6. FAA FORM 7230-10, POSITION LOG

2. BACKGROUND: In recent years, many new terminal position types have been created, but the order has not been updated to reflect them. Additionally, in the absence of a revised order listing the names of the new position types, facilities have been making up their own names for certain types of positions. There has been no consistency in the names they have used. Consequently, when facilities enter position types into the computer (for example, to update "Business Objects"), it is difficult to relate the information from one facility to the information provided by another facility.

3. EXPLANATION OF CHANGE: The recommended new table solves the problem by standardizing the names of the position types throughout terminal. Moreover, the new list divides the names among three categories of terminal facilities: Tower, TRACON, and Tower/TRACON. This change cancels and incorporates N JO 7210.714, FAA Form 7230-10, Position Log, effective June 6, 2009.
