Dear Ms. Yarnell:

I am the Aeronautical Center Counsel, and I advise the FAA Aircraft Registry with respect to aircraft recordation matters.

On November 20, 1986, the FAA Aircraft Registry received the enclosed document from your office. Upon review thereof, it appears to be a petition for judgment against Vincent Bashore, Assessee, as relates to unpaid taxes, penalties and interests concerning civil aircraft N3176V.

Thereafter, on the same document, there is an "Abstract of Judgment" reflecting that a judgment was issued against the assessee in the amount sought (\$171.28).

Pursuant to Sections 101(20) and 503 of the Federal Aviation Act, the FAA Aircraft Registry will only record conveyances. That is, instruments which affect an interest in property (in this case an aircraft).

The enclosed document only indicates judgment against an individual. Further, we would record only the document itself (e.g., the judgment order rather than an abstract).

For the above reasons, I have advised the FAA Aircraft Registry not to record your document.




