  2. **Purpose:** This Order modifies Safety Element Approval No. SEA 24-009 issued concurrently by the Federal Aviation Administration's (FAA) Office of Commercial Space Transportation (AST). This Order prescribes as conditions to the Safety Element Approval certain requirements applicable to the approved safety element.
  3. **Scope:** The safety element is for a software product called TIPQA Quality Management Solution to maintain records to satisfy the record keeping portions of 14 CFR §§ 420.61, 450.219(b), and 450.173(g).
  4. **Document Management and Record Retention:** Deltek, Inc. may offer TIPQA Quality Management Solution as a component of the process to provide document management capabilities designed to ensure accurate and thorough record retention throughout the lifecycle of licensed site or vehicle operations, as required by 14 CFR §§ 420.61, 450.219(b), and 450.173(g).
  5. **Safety Element Approval Term:** Safety Element Approval No. SEA 24-009 terminates five (5) years from March 29, 2024.
