Determination Regarding the Extent to which Launch Safety-Related Services and Property of Goddard Space Flight Center Wallops Flight Facility Satisfy Part 450 Requirements

**AGENCY:** Federal Aviation Administration (FAA), Department of Transportation (DOT)

**ACTION:** Notice of Determination

## **SUMMARY:**

In accordance with 14 CFR 450.45(b), the FAA has provisionally determined that the launch safety-related services and property of the Goddard Space Flight Center Wallops Flight Facility (GSFC/WFF), satisfy the requirements of Part 450 specified in the table below. A final determination is pending additional coordination between GSFC/WFF and the FAA.

**SUPPLEMENTARY INFORMATION:** The Commercial Space Launch Act of 1984, as amended and codified at 51 U.S.C. §§ 50901-50923, authorizes the Department of Transportation, and the FAA through delegation, to oversee, license, and regulate commercial launch and reentry activities, and the operation of launch and reentry sites as carried out by U.S. citizens or within the United States. The FAA exercises this responsibility consistent with public health and safety, safety of property, and the national security and foreign policy interests of the United States. 51 U.S.C. 50905. To satisfy the FAA regulations, operators may use a means of compliance that has already been accepted by the FAA or propose an alternate approach.

**DETERMINATION:** In accordance with 14 CFR 450.45(b), the FAA has provisionally determined that the launch safety-related services and property of the GSFC/WFF satisfy the requirements of Part 450 specified in the table below. A final determination is pending additional coordination between GSFC/WFF and the FAA. Applicants are free to apply for listed services

under this provision prior to a final determination. The FAA expects to expand this determination to encompass additional requirements through the coordination process. The FAA may also accept services and property provided by GSFC/WFF as satisfying additional requirements on a case-by-case basis.

The services have been determined to satisfy the regulations for the following scope of operations:

- Vehicle types
  - o Thrust vector controlled and thruster-controlled vehicles
  - o Propellants with CSWG-established yield curves
- Operations
  - o Launching vertically from WFF

This determination does not obligate GSFC/WFF to provide services or property to an operator. The FAA will accept services and property specified above as satisfying application requirements for a Part 450 license provided they are specified in an agreement between the operator and GSFC/WFF (or a chain of agreements through a third party).

The FAA plans to publish an Advisory Circular in the near future that provides guidance on submitting an application under Part 450 that specifies services and property provided by a Federal Entity to satisfy requirements.
