Satellite Voice (SATVOICE) Guidance Material (SVGM)

(Presented by the FAA on behalf of the Inter-Regional SATCOM Voice Task Force)

#### Summary

This paper provides an update on Inter-Regional Satellite Communications (SATCOM) Voice Task Force (IRSVTF), and invites the ISPACG/FIT to support completing globally applicable guidance material for using SATVOICE for air traffic services communication (SVGM), targeted for March 2012.

## **1 INTRODUCTION**

- 1.1 At ISPACG/25 FIT/18, the FAA presented a paper on the work of the Inter-Regional SATCOM Voice Task Force (IRSVTF).
- 1.2 The NAT Systems Planning Group (SPG) and Asia/Pacific Air Navigation Planning and Implementation Regional Group (APANPIRG) mandated IRSVTF to produce globally applicable guidance material for using satellite voice for air traffic service (ATS) communications (SVGM) (Refer to NAT SPG Conclusion 46/5 and APANPIRG Conclusion 21/27a).
- 1.3 This paper provides an update on the work of the IRSVTF and invites the ISPACG/FIT to support completing the SVGM, targeted for March 2012.



#### 2 DISCUSSION

- 2.1 Since ISPACG/25, the IRSVTF held four virtual meetings and two face-to-face meetings (IRSVTF/2 and IRSVTF/3) to progress the draft SVGM.
- 2.2 A draft of the SVGM, v0.8.6, is provided at <u>Attachment A</u> and the associated comment matrix is provided at <u>Attachment B</u>.
- 2.3 The draft SVGM is structured similar to the Global Operational Data Link Document (GOLD). <u>Table 1</u> shows the current document outline and intended uses.

- 2.4 Similar to GOLD, the ICAO EUR-NAT (Paris) and Asia-Pacific (Bangkok) Regional Offices will coordinate with ICAO HQ (Montreal) to maintain the SVGM as a global document and to facilitate timely completion.
- 2.5 Operational Data Link Panel (OPLINKP) work program includes amendments to ICAO Annexes/Procedures for Air Navigation (PANS) and Guidance material related to use of SATVOICE for ATS communications. OPLINKP is monitoring the IRSVTF work to assess ICAO material needed for approval at the 12th Air Navigation Conference in November 2012. The IRSVTF will provide recommendations, as necessary, to OPLINKP by March 2012.
- 2.6 ICAO is sponsoring a web site to support the work of the IRSVTF on the ICAO Secure Portal web site (you may already be a member of various ICAO global groups on this web site). A group exists on this web site entitled IRSVTF and you are invited to register as a member of the IRSVTF as soon as it is convenient to you and start using the service. If you are already registered on the web site, you need only to request a membership to the group IRSVTF through your Profile link. If you do not have an account with the ICAO Secure Portal web site, follow the instructions below to subscribe and gain access to the web site:
  - a) Access the ICAO Portal at the following link: http://portal.icao.int;
  - b) Since you do NOT have a Portal username/password, click the REQUEST AN ACCOUNT option;
  - c) Click the OK button on the pop-up message to indicate this is your first Portal account. In the pop-up window, enter the group name (all caps and no spaces) IRSVTF in the SUBSCRIBE TO field;
  - d) Click the OK button;
  - e) Enter the necessary information in the New User Account form; and
  - f) Click the SUBMIT REQUEST button.
- 2.7 When the above steps are completed, you will receive confirmation that you have been granted or denied access (if granted, the email will include your username and password). If you should require further information or assistance, please contact "Catherine DALY" <cdaly@paris.icao.int>.
- 2.8 If you are participating in the IRSVTF, it is important that you obtain access to the IRSVTF web site, as this web site will be used to post the latest draft versions of SVGM and the comment matrix, and to notify members of updates.



2.9 **Figure 1** provides an updated schedule. The IRSVTF is targeting SVGM, First Edition, in March 2012, to support endorsement by NAT SPG/48 (June) and APANPIRG/23 (September).
