**SUPPLEMENTARY INFORMATION: Section** 149 of the Federal Aviation Administration Authorization Act of 1996, Pub. L. No. 104-264 (October 9, 1996) (1996 Reauthorization Act), added a new § 47134 to Title 49 of the U.S. Code. Section 47134 authorizes the Secretary of Transportation, and through delegation, the FAA Administrator, to exempt a sponsor of a public use airport that has received Federal assistance from certain Federal requirements in connection with the privatization of the airport by sale or lease to a private party. Specifically, the Administrator may exempt the sponsor from all or part of the requirements to use airport revenues for airport-related purposes (upon approval of 65 percent of the air carriers serving the airport and having 65 percent of the landed weight), to pay back a portion of Federal grants upon the sale of an airport, and to return airport property deeded by the Federal Government upon transfer of the airport. Since Niagara Falls International Airport is a general aviation airport without air carrier service, the 65 percent approval of air carriers is not required. The Administrator is also authorized to exempt the private purchaser or lessee from the requirement to use all airport revenues for airport-related purposes, to the extent necessary to permit the purchaser or lessee to earn compensation from the operations of the airport.

On September 16, 1997, the FAA issued a notice of procedures to be used in applications for exemption under Airport Privatization Pilot Program (62 FR 48693). The notice of procedures and public comments received are available for review in FAA Rules Docket No. 28895.

On June 5, 2000, NFTA filed a final application and selected Cintra Niagra Falls Airport Corporation, USA, as the airport's private operator. Cintra Niagara proposes to lease the airport under a 99year lease agreement. It plans to market the airport to develop new services such as low cost domestic passenger flights to business and leisure centers, international charters and cargo services. Cintra Niagara will commit \$10.1 million in the initial 13 years for the purposes of operating, managing and developing the airport. \$1.125 million will be used for operating, marketing and capital improvement costs. The remaining \$8.975 million will be used for marketing expenses and to fund the initial five year capital planning period.

The public meeting scheduled for March 19, 2001, will begin at 7 p.m. in the school auditorium of the Niagara County Community College, 3111 Saunders Settlement Road, Sanborn, NY. NFTA, the airport owner, will provide a brief presentation of the privatization initiative followed by public comments on the IAG final application for inclusion in Docket No. 28895 and considered by the FAA in making its decision on the application. American Sign Language interpretative services will be available. Registration for individuals wishing to speak will begin at 6:30 pm directly outside the auditorium. Because the IAG final application is presently before the agency for a decision, the FAA will not be able to discuss the application or the pending agency decision.

- Glenn Rizner, Vice Chair, Acting Chair for this meeting, called the Aviation Rulemaking Advisory Committee (ARAC) Executive Committee (EXCOM) meeting to order at 10:05 a.m.
- Tony Fazio, the ARAC Executive Director, read the Federal Advisory Committee Act (FACA) statement. Introductions were make around the meeting room.

**Review and Approval of Minutes of Previous Meeting** 

The minutes from the February 7, 2001, meeting were reviewed by the EXCOM members. A motion was made to accept the minutes. The motion was approved and the minutes from the February 7, 2001, meeting were adopted.

# Presentation by Ken Susko, Aviation Safety Facilitators Corp. (ASFC)

Mr. Susko briefed the Executive Committee on a design concept ASFC believes will help ARAC address the Fuel Tank Inerting issue. Mr. Susko's concept utilizes Ground-Based Inerting along with On-Board Inerting to achieve 100% effectiveness, addresses remote operational aircraft concerns, and on-board liquid nitrogen to inert fuel tanks. A copy of the briefing is attached.

Mr. Larson and Mr. Priddy both voiced their concerns regarding the use of a nitrogen based system.

Mr. Rizner inquired about servicing times with properly trained personnel. Mr. Susko agreed with

Mr. Rizner that this is a major concern of his concept.

## Status Report: Fuel Tank Inerting Working Group

- The Executive Committee Update and Concept Review was presented by Co-Chairpersons Brad Moravec and Sean O'Callaghan.
- Mr. O'Callaghan explained the design concepts. This included the Ground-based Fuel
  Tank Inerting System, Onboard Ground Inerting, On-board Inert Gas Generating System,
  and the Hybrid On-board Ground Inerting. During the second half of the briefing, Mr.
  Moravec addressed Rulemaking and Compliance, and the major milestones. The working
  group will begin drafting. The first draft will be reviewed at the next working group
  meeting planned for May 15-17 at the Tech. Center. The working group believes they are
  still on target and will have their task completed on the scheduled date.
- After the briefing, Mr. O'Callaghan and Mr. Moravec answered EXCOM guestions.
- A number of questions addressed costs and aircraft turn-a-round time. Sean explained there are preset turn-a-round times for different aircraft types. These times would need to be adhered to if costs are to be kept minimal.
- Paul Larson asked for some ball-park figures. Mr. Moravec stated, these figures were incomplete at this point, but should be available at the next Excom meeting.
- Rod Priddy recommended that Mr. Susko's presentation should be considered by the working group.
- A question was raised about environmental issues and consequences. Mr. Moravec stated this will be documented in the working group's report to the FAA, but the working group was not going to tackle EPA regulations at this time.
- It was inquired if the working group had been able to review the Pentagon's report regarding On-Board Gas Generating Systems. Mr. O'Callagan assured the members the working group had the opportunity to review and discuss this report.

Following the briefing, the Executive Committee approved the working group's request to begin drafting their report.
