What is it?

Upon completing the Sign Up for SAS process, CH/As can log into SAS

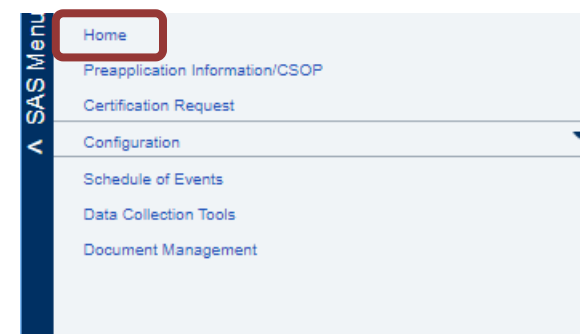
Certificate Holders and Applicants (CH/As) use their MyAccess account to log into the SAS External Portal. Logging into the SAS External Portal takes CH/As to the SAS Home Page.

Tiles on the SAS Home Screen

The SAS Home Screen has three default areas referred to as *tiles*: **Notifications**, **Messages**, and **Broadcasts**.

Applicant Data Review

The SAS Menu includes links to quickly navigate around the SAS External Portal. Data will not be viewed by the FAA until after a Certification Project Manager has been assigned to the certificate – even though the Applicant is able to log in and enter data in the SAS External Portal.
