Federal Aviation Administration (FAA) Authorized Flight Instructor Refresher Course (FIRC) Provider List

The FAA's General Aviation and Commercial Division is responsible for the policy governing the FIRC program. The Division also evaluates submissions from, and issues approvals to, qualified candidates requesting authorization to become a FIRC provider. In addition, appropriate FAA Flight Standards District Offices (FSDO) review and approve requests from provisional pilot schools and pilot schools seeking to add a FIRC curriculum under their Air Agency Certificate. The current iteration of FAA Advisory Circular (AC) 61-83 provides guidance and recommendations for the preparation and approval of training course outlines (TCO) for FAA-approved, industry-conducted, FIRCs in accordance with Title 14 of the Code of Federal Regulations (14 CFR) § 61.197(b)(2)(iii).

When the FAA receives an authorization request, the General Aviation and Commercial Division, or the managing FSDO of a provisional pilot school or pilot school holding an Air Agency Certificate under 14 CFR part 141, as applicable, conducts a thorough review of the applicant's TCO. Candidates hold full responsibility for the development of their TCO and the compliance of their subsequent FIRC presentations to the conditions of authorization. The FAA issues an approval in the form of a letter of authorization (LOA), unless authorized as an approved curriculum under a part 141 Air Agency Certificate. FIRC LOAs are valid for 24 calendar months.

The FAA requires all FIRC providers to have a copy of their LOA and TCO available at each FIRC presentation. This requirement allows attendees and observing FAA Aviation Safety Inspectors (ASI) to review the LOA and TCO prior to the start of any FIRC, if requested. The FAA provides guidance for ASI oversight in FAA Order 8900.1, Volume 6, Chapter 11, Section 8, *Inspect a Flight Instructor Refresher Course*.
