Dear Sir,

This letter aims at informing FAA how, in the context of the Agreement between the UNITED STATES OF AMERICA and the European Community on cooperation in the regulation of civil aviation safety, the civil aviation competent authority in France is organised.

The DSAC (Civil Aviation Safety Directorate) has delegated since 2010 some oversight activities to OSAC, (Organisme pour la Sécurité de l'Aviation Civile) in the field of maintenance, production, continued airworthiness organisations, licenced mechanics, maintenance training organisation.

In 2022, after a call for tender organised by DSAC, OSAC won and is designated as DSAC representative in order to continue its mission for the period starting on the 1st of January 2023 until 31st of December 2028. OSAC is recognised through the official "arrêté" dated 27 July 2022 published in the Official Journal of the French Republic which identifies the scope of activities in its annex:

OSAC has been granted by DSAC the privilege to sign documents on its behalf, such as organisations certificates, export CofA, Statement of compliance with FAA type certificates. Depending on the subject, FAA representatives may receive either a letter from DSAC, or from OSAC, as part of the French Competent Authority.
