What is it?

Certificate Holder Registration

After completing the MyAccess process, information must be entered, submitted, and approved to link their company to their MyAccess account.

Approval by the FAA

- The users must await approval by the FAA before they can log into SAS for the first time
- The user must have a MyAccess account in order to log into the SAS External Portal
- Upon logging in to an active Certificate Holder or an in progress certification, users will have full access to all available external user functionality

Current "EXC\" Account Users

External Users who currently use the EXC\first.last user name and password have the ability to switch to MyAccess at any time. Once the transition has occurred, they cannot use their EXC\ account to log into the SAS External Portal.

Currently, the SAS External Portal only supports Applicants and Certificate Holders operating under 14 CFR Parts managed within SAS. Please read the instructions on this page to apply for a secure FAA User Name/ID that you can use to access the SAS External Portal.
