## What is it?

### Certificate Holder Registration

After completing the MyAccess process, information must be entered, submitted, and approved to link their company to their MyAccess account.

### Approval by the FAA

- The users must await approval by the FAA before they can log into SAS for the first time
- The user must have a MyAccess account to log into the SAS External Portal
- Upon logging in to an active Certificate Holder or an in-progress certification, users will have full access to all available external user functionality
