An InFO contains valuable information for operators that should help them meet certain administrative, regulatory, or operational requirements with relatively low urgency or impact on safety.

Subject: 2011-2012 Holdover Times Tables (HOT)

Purpose: This InFO serves to inform operators of two things:

- 2011-2012 HOTs,
- AFS-200's Aircraft Ground Deicing website's notification feature.

Background: Publication of the HOTs and companion notice for de/anti-icing fluids and subsequent amendments of these documents, have in the past, caused confusion in regards to version control for both the industry and Federal Aviation Administration (FAA) inspectors. To eliminate version control problems and ensure that everyone is kept informed about the initial publication and subsequent amendments if any, of these documents, AFS-200 has setup a notification feature for the Aircraft Ground Deicing website.
