Airman Knowledge Test Questions

Does the FAA publish a list of all the airman knowledge test questions?

The FAA does not release ‘live’ airman knowledge test questions to the public. However, you can view sample airman knowledge test questions and take practice exams under the “Exam Resources” tab of the [PSI True Talent Website](#).

Do the airman knowledge test questions ever change?

Yes. The FAA continuously adds, reviews, and revises airman knowledge test questions to keep airman knowledge tests accurate and current, address changes in regulations, guidance, and technology, and protect and enhance airman knowledge test integrity and security.

Does everyone take the same airman knowledge test for a particular airman certificate?

No. All airman knowledge tests for a given airman certificate or rating include questions covering the required knowledge areas. Still, the sequence and wording of the questions will vary with each test.

Airman Knowledge Test Process

Preparing for the test . . .

How should I prepare for the knowledge test?

You should prepare for the knowledge test by reviewing the applicable regulations and guidance. For **Pilots**, review [14 CFR Part 61](#) and the [FAA Airman Knowledge Testing Matrix](#). For **Aviation Maintenance Technicians (Mechanics)**, review [14 CFR Part 65](#) and the [FAA Airman Knowledge Testing Matrix](#).

Scheduling the test . . .

Where can I find a list of sites that administer airman knowledge tests?

Documents needed for the test . . .

What documentation do I need to take an airman knowledge test?

You can refer to the [FAA Airman Knowledge Testing Matrix](#) for information on identification, eligibility, and authorization requirements for airman knowledge testing and retesting.

What is an authorization to take an airman knowledge test?

An authorization is documented evidence that you meet the requirements to take or retake an airman knowledge test. You can find information on acceptable forms of airman knowledge tests and retest authorizations in the [FAA Airman Knowledge Testing Matrix](#).

What constitutes an "endorsement" to take an airman knowledge test?

For **Pilots**, review [AC 61-65H – Certification: Pilots and Flight and Ground Instructors](#) and the [FAA Airman Knowledge Testing Matrix](#) for information on what constitutes an endorsement to take a pilot's airman knowledge test. For **Aviation Maintenance Technicians (Mechanics)**, review [14 CFR part 65, subpart D](#), and the [FAA Airman Knowledge Testing Matrix](#) for information on what constitutes an endorsement to take a mechanic's airman knowledge test.

Do all airman knowledge tests require an endorsement?

No. The [FAA Airman Knowledge Testing Matrix](#) indicates which airman knowledge tests require an endorsement.

What may I do if I am an international student who wishes to take an airman knowledge test, but my passport has expired, and I cannot renew it due to my pending asylum status?

If you do not possess a current passport due to your asylum status, you may present official, government-issued documentation to an FAA Flight Standards District Office or International Field Office for approval as a form of acceptable identification instead of a passport. The field office will notify the Airman Testing Standards Branch of your approval or disapproval.

Results of the Test . . .

What happens if I fail the airman knowledge test?

Airman Knowledge Test Reports (AKTRs)

What is an AKTR?

You will be given an AKTR (score report) upon completing your airman knowledge test. It shows your name and FAA Tracking Number (FTN), your score, and Learning Statement Codes (LSCs) or Airman Certification Standards (ACSs) codes related to any questions you may have answered incorrectly. Other details unique to your airman knowledge test are also displayed on the report.

What do I do with my AKTR?

After you complete an airman knowledge test, the testing center proctor will issue you a printed AKTR, which shows your score and codes related to any questions you may have answered incorrectly. You will need to retain your original AKTR, so an evaluator may review any noted areas of deficiency, with you, during the oral portion of your practical test.

How do I get a copy of my AKTR?

If you took an airman knowledge test on or before January 10, 2020, follow the instructions at [14 CFR Section 61.29](#) to request a replacement copy of your AKTR. If you took an airman knowledge test on or after January 13, 2020, you may print a duplicate AKTR from the [PSI True Talent Website](#).

Where can I find information about the Learning Statement Codes or Airman Certification Standards Codes on my AKTR?

You can refer to the [Learning Statement Reference Guide](#) or applicable [Airman Certification Standards](#) document to identify the areas related to questions you missed on the test.

What should I do if my name on the AKTR differs from what is shown in the Integrated Airman Certification and Rating Application (IACRA) system?

If the AKTR shows your name incorrectly, you must present proof of your correct information when you take your practical test or apply for your certificate. If you choose to have your name corrected at the time of your practical test, the test examiner must provide a certifying statement that you presented the correct information. The test examiner's statement and a photocopy of your identification must accompany your certification file, which is then forwarded to the FAA's Airmen Certification Branch.
